APPROVED PRODUCTS/QUALITY POLICY

- 1. ShowerFix aim to provide the best quality and value to our customers.
- 2. Customers need to have confidence in the solution we have proposed or that they have paid for.
- 3. Replacement parts for ALL showers MUST be the correct parts designed for that shower unless that part is not available. "Not available" means the part is no longer available for purchase or manufacture (including 3D printing) anywhere. It does not mean "I didn't have one in my van at the time" or "I was saving money/making better margin" by supplying an incorrect part.
 - This is particularly important when fitting door seals. ie; Athena doors require Athena seals etc.
- 4. All customers being quoted for any liner, tray, door, return, bath screen, or "full enclosure" (FE) must be offered a solution using "A" category supplier's product. In addition to this you may also want or need to offer them a "B" category solution. "Offered" means they have had any options clearly communicated either in writing or verbally so that they have been able to respond one way or the other.
 - -There are obviously situations where this does not apply. For example, where you are replacing a part of an existing Chinese shower and nothing else will fit.

Products designed for NZ/AU market that meet, and are expected to meet during their reasonable lifetime, the NZ Building Code.

Products designed in NZ and or made in NZ.

A NZ national footprint of retailers and access to supply.

Full design and technical back-up in-house.

Full technical warranty back-up with knowledgeable staff.

High quality materials and design.

A reasonable expectation the product will last beyond its warranty period.

A reasonable expectation the supplier will be around till the warranty expires.
